


Affordability


- Ownership structure

Current stock

- Only 4% owned by municipalities
- 1200 units owned by City
- The stock needs to be supervised, renovated, repurposed, and also revision in legislation

ESZKÖZÖK:


- Magánlakásokat bevonó házkezelő szolgáltatás
